

Resolution 2016 Sweepstakes

OFFICIAL RULES

No purchase, obligation or transaction necessary TO ENTER THE SWEEPSTAKES.

Promotion Period: Resolution 2016 ("Sweepstakes") begins January 1, 2016 and ends February 29, 2016. Entries received prior to or after the Promotion Period are not eligible for the Sweepstakes.

How to Enter: Individuals will receive an automatic entry into the Sweepstakes when they log into ILLINOIS STATE CREDIT UNION'S PERSONAL FINANCE MANAGER between January 1, 2016 and February 29, 2016, and have added at least one financial goal. One entry per household.

ILLINOIS STATE CREDIT UNION and contest sponsor – Debtfolio, Inc. dba Geezeo – are not responsible for entries that are lost, misdirected, delayed, destroyed, deleted, erased, stolen, or unreadable. ILLINOIS STATE CREDIT UNION and Geezeo assume no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. For a selected entry to be declared a winner, the winning individual must satisfy all of the requirements as listed in these Official Rules. Winners need not be present and will be notified by e-mail, mail or telephone within 5 business days of selection. If a winning individual does not affirmatively accept his or her prize in writing or via e-mail within 10 calendar days of notification, an alternate entrant will be selected at random in his or her place from all eligible entries received.

Prize winners will be required to sign an affidavit of eligibility and liability/publicity release which must be returned within 10 days of notification. Arbitrator decisions are as enforceable as any court order and are subject to **VERY LIMITED REVIEW** BY A COURT. The place of arbitration shall be in the County in which you reside.
