About the Position:

We are looking for an IT Systems Technician to join our team! The IT Systems technician is responsible for design, implementation, configuration, upgrade, monitoring, troubleshooting, and administration of Illinois State Credit Union's critical server technology software and hardware infrastructure. This includes public cloud, software as service offerings, and multiple system integrations across various vendors.

Technology: Coordinates and/or performs additions and changes to infrastructure hardware and operating systems, business applications, and desktop hardware. This includes investigation, analysis, recommendation, configuration, installation, and testing of new hardware, software, automation, and system integrations. Participates in planning design, technical review, and implementation for all new IT system systems (not limited to: IT services, new business applications, integrations, automation, or new service offerings).

Support: Provides escalated technical support in the day-to-day operations on all Illinois State Credit Union technology; duties include evaluation of system utilization, monitoring response time, and primary support for detection and correction of operational problems.

System Standards, Security and Documentation: Define and maintain IT system and infrastructure standards (including security hardening for systems). Define, create and maintain standard operating procedures for each supported system. Develop standard operating procedures for the Service Desk for front line support. Create and maintain technical design documentation for each supported system. Create and Maintain DR



documentation and ensure all systems configurations and changes match and comply with DR policies. Actively participant in DR exercise, roundtables, and testing.

- Participation in on-call rotation
- Aware of cybersecurity security frameworks and application in technical design/implementation
- Preferred candidates will have design/implementation experience with the following:

- Knowledge of VPN access/profiles.
- Knowledge regarding domain controllers and server maintenance.
